

ACTA Meeting  
for  
August 11, 2004

The ACTA meeting was called to order by President, Jim Arnold. The meeting was held in the Hot Springs Convention Center at 3:00 p.m.

ORDER OF BUSINESS:

1. Jim Pinner presented a \$500 scholarship to Susan Shurley, daughter of Jo Rene Shurley, Lonoke County Treasurer. Jim Arnold presented the Association scholarship of \$500 to Tyler Humphries, son of Larry Humphries, Fulton County Treasurer.
2. Minutes and financial report were approved with correction: add Vivian Hightowner to the retiree list.
3. New Continuing Education Board was recognized: Kim Graham of Van Buren County and Sandra Beck of Monroe County.

6. Charlotte Davis addressed the full body concerning the Common School. She asked about getting the law changed and closing all of them across the state. She further stated that this money should be going to County General. Charles Barnett moved to explore the idea of deleting these positions. Second by Jo West Taylor. Motion passed unanimously.

7. Charles Barnett distributed copies of two resolutions: 1) Extension of Term Limits  
2) Authority to approve general obligation bonds to fund economic development projects.  
A motions was made to amend the heading on both resolutions to read “Arkansas County Treasurers Association”. Amendment and motion to support the resolutions passed unanimously.
